SUMMARY:

The Accountant is responsible for applying principles of accounting to analyze and maintain governmental financial records utilizing appropriate accounting control procedures.

QUALIFICATION REQUIREMENTS:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform essential functions.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

The following duties are representative of the work required for this job. These are not to be construed as exclusive or all-inclusive. Other duties may be required and assigned.

1. Maintains the general ledger, prepares and posts entries, reviews and approves journal entries, prepares monthly journal vouchers, reviews data for accuracy, prepares financial reports, and prepares year-end closing.
2. Reconciliation of accounts and complex transactions
3. Preparation of reporting requests as required by governmental and other external agencies.
4. Reviews capital outlay purchases to approved budget prior to purchase order issuance.
5. Oversees the processing of travel advances and expense reports.
6. Prepares grant reports for reimbursements and maintains records in accordance with Federal and State laws.
7. Assists internal and external auditors by providing data needed to complete audits.
8. Administers billing for a wide variety of programs including the Macon-Bibb County Health Department, indigent defense
9. Administers monthly mapping billing.
10. Performs analysis of general ledger accounts for missing payments and incorrect entries.
11. Capital Asset reporting and monitoring.
12. Assist with review and processing of selected disbursements

KNOWLEDGE, SKILLS, AND ABILITIES:

The Accountant must be knowledgeable of the following principles, procedures, and concepts:

1. Knowledge of generally accepted accounting principles and practices; preferable governmental accounting
2. Ability to check, verify and balance accounts to general ledger.
3. Knowledge of applicable local, state, and federal laws and regulations pertaining to finance and accounting.
4. Knowledge of methods and techniques of research, statistical analysis and report preparation.
5. Ability to plan, coordinate, and organize work; set priorities and meet critical deadlines.
6. Ability to communicate effectively both orally and in writing with members of all levels within the organization.
7. Skill in using personal computers and relevant office programs.
8. Ability to resolve problems in a timely, efficient, and effective manner.

MINIMUM EDUCATION, TRAINING AND/OR EXPERIENCE TO PERFORM ESSENTIAL JOB FUNCTIONS:

The Accountant should possess, at a minimum, a Bachelor's Degree in Accounting, Finance, or Business Administration; some experience in accounting is preferred; or any equivalent combination of education and experiences which provides the required knowledge, skills, and abilities to successfully perform the duties and responsibilities of the position.
