5.0 Questions:

Item	Description of Change
5.1	Question: Detail 8/A2.1 – Note at vertical bars says see structural, Stuctural says see Architectural. This appears to be a 4" concrete block. You cannot put anything larger than a @ 2 rebar in a 4" block and you cannot fill a 4" block with grout.
	Response: Steel rebar is not required. Provide horizontal joint reinforcing at 16" in the C.M.U. Grout all cores solid. At the thin stone veneer, install and anchor per manufacturer's written instructions. This is typically Portland Cement scratch coat, expanded metal lathe, and mortar setting bed - coordinate with manufacturer(s).
5.2	Question: Detail "Frame Plan – Open Pavilion on sheet S3.0: Dimensions left to right add up to 39'-4" – not 36'. Response: 39'-4" is the correct overall dimension.
5.3	Question: Arch sheets A4.2 show exterior walls with footing and waterproofing but also says see structural for details. Structural shows only a turndown slab. Which do you want and do you still want the waterproofing shown on the architectural and, if so, where do you want waterproofing if you have a turndown slab?
	Response: Waterproofing is not required for any of the pavilions.
