CIVIL JURY TRIALS 4/3/17 ~ 4/10/17

No civil case shall be considered ready for trial or called at calendar call unless notice is given in writing or by email and received by the judge's secretary no later than fifteen (15) calendar days immediately prior to the first day of the trial term, stating the case is "ready" for trial. This "15 day letter" or "ready letter" shall be served upon opposing counsel by mail, email or in person at the same time the letter is given to the Court.
