Instructions: An application for a permit must include the Applicant's Erosion and Sediment Control Plan and must be factual and complete. Upon completion, the application must be submitted to the address shown above with a permit fee (\$80.00 per acre or fraction thereof in the project area).

Pursuant to the requirements to the Erosion and Sedimentation Act of 1975, as amended, and the Rules of Georgia Department of Natural Resources, Environmental Protection Division, Chapter 391-3-7 Erosion and Sedimentation Control, and the Code of Macon-Bibb County, Georgia, the undersigned hereby applies for a permit for land disturbing activity as indicated herein and represented by the attached plans.

LAND DISTURBANCE ACTIVITY PERMIT

In accordance with the provisions of the Erosion and Sedimentation Act of 1975, as amended, and the Rules of the Georgia Department of Natural Resources, Environmental Protection Division Chapter 391-3-7, Erosion and Sedimentation Control, and The Code of Macon-Bibb County, Georgia promulgated pursuant thereto, this permit is issued for the land disturbing activity as recorded herein and presented on the attached Approved Erosion and Sediment Control Plan which is hereby a part of this permit.

This permit is subject to modification or revocation on a finding of noncompliance with any of the provisions of the Erosion and Sedimentation Act of 1975, as amended, or any of the rules promulgated pursuant thereto; or with any representation made on the attached thereto.

This permit is effective from the date issued **not to exceed an elapsed time of twelve (12) months** or until completion of the aforementioned land disturbing activity and is contingent upon the permittee complying with the conditions as indicated on this permit.

NOTES

- #1. **Commercial, Industrial, and Institutional projects** - NO work may begin until Zoning Compliance is granted. Copy of PERMIT & PLANS must be submitted to Macon-Bibb County Planning & Zoning Commission.
- #2. **Land Subdivisions** - NO work may begin until the LDA Permit is issued. (This Permit is your authorization to commence work.)
- #3. ANY LAND DISTURBING ACTIVITY CONSTRUCTION (INCLUDING ACTIVITIES WITHIN AN AREA OF SPECIAL FLOOD HAZARD, WETLANDS, ETC.) MAY BE SUBJECT TO REGULATION OF OTHER LOCAL, STATE, OR FEDERAL AUTHORITIES, AND APPLICANT MAY BE REQUIRED TO OBTAIN ADDITIONAL PERMITS PRIOR TO COMMENCEMENT OF CONSTRUCTION OF LAND DISTURBANCE ACTIVITY.
