Alcohol Handler's Beverage License Application

APPLICATION INSTRUCTIONS

Alcohol Handler's Licenses are issued to individuals, not businesses, and may be used by the same individual for any number of employers or businesses where the licensee works as an Alcohol Handler. Effective April 1, 2019, it shall be a violation of the Macon-Bibb County Code of Ordinances for any person to work as an Alcohol Handler without an Alcohol Handler's License.

A. The following people are Alcohol Handlers, and must obtain an Alcohol Handler's License:

- 1) Anybody working as an employee or independent contractor for a business that does not earn at least 50% of its gross annual revenues from the sale of food, and whose normal job duties include pouring, mixing, or opening alcoholic beverages for sale by the drink;
- 2) Anybody working as an employee or independent contractor for a business that does not earn at least 50% of its gross annual revenues from the sale of food, and whose normal job duties include supervising or managing any person whose normal job duties include pouring, mixing, or opening alcoholic beverages for sale by the drink;
- 3) Anybody with at least 25% ownership in any business selling alcoholic beverages at retail, whether by the package or by the drink, unless the business is a publicly-traded company; AND
- 4) Any person serving as the agent on any Macon-Bibb County license for the sale of alcoholic beverages at retail, whether by the package or by the drink.

B. **The fee is \$25.00.** Alcohol Handler's License fees are not prorated and expire on December 31st of each year.

ADDITIONAL DOCUMENTS TO BE SUBMITTED

In addition to completing the attached forms, a complete application **MUST** include each of the following documents:

1. A certificate showing completion of an alcohol handler's training course, approved by Macon-Bibb County, within the last three years. A separate fee may apply. See attached list of approved courses.
2. An unexpired identification card issued by any U.S. State or The United States government, bearing a current photograph of the applicant.
3. Two current color passport size photographs of applicant.
