### C. Bid Bond

- 1. Bids, in order to be considered, shall be accompanied by a bid bond, payable to the Owner, in amount not less than five percent (5%) of the total base bid.
  - a) This bid security shall become payable to the Owner only if the bidder, to whom award is made, should fail to execute a contract with the Owner and furnish bond and insurance in accordance with terms of the contract within ten (10) days after notification of award.

## A. Validity

1. No bid may be withdrawn for a period of ninety (90) after time has been called on date of bid opening.

#### B. Contract Award

- 1. The contract, if awarded, will be based on total bid price.
- 2. All prices shall be Delivered prices, FOB Destination, after deducting all non–applicable taxes.

### II. INSTRUCTIONS TO BIDDERS

## A. Document Discrepancies

- 1. Should the bidder find discrepancies in, or omissions from the documents, he shall at once notify the Macon-Bibb County Procurement Department.
- 2. Requests for Interpretations of Drawings and Specifications shall be made in writing to the Macon-Bibb County Procurement Department not later than seven (7) days prior to receipt of bids, email preferred to <a href="mailto:ntharpe@maconbibb.us">ntharpe@maconbibb.us</a>.
- 3. Any subsequent instructions to bidders will be issued in the form of addenda to the specifications and sent to the bidder. All addenda shall be enumerated in the Bid Form.
- 4. All definitions set forth in the specifications are applicable to this Instruction to Bidders, the Bid Form and the proposed Contract Documents including, but not limited to, drawings, project manual, and any addenda issued prior to receipt of bids.
  - a) Addenda are written or graphic instruments issued prior to the execution of the Contract that may modify or interpret the bidding documents by deletion, additions, clarifications, or corrections.
  - b) Addenda will become part of the Contract Documents when the Contract is executed.

- C. Following is an Invitation to Bid on vehicle setups:
  - a) Setups for nine (9) 2021 Dodge Chargers, Pursuit, V8 Engine. Part numbers and descriptions on the bid form are manufacture's name and part numbers used for 2020 vehicles. Companies wishing to bid will need to verify these part numbers and descriptions are comparable with the 2021 vehicles. Lights shall be blue.

### D. Reservations

- 1. The bidder acknowledges that Macon-Bibb County reserves full freedom (in addition to the right to reject any and all bids) in awarding bids to consider all available factors including, but not limited to, price, the provision of needed and unneeded features, usefulness to the using department and prior County experience. In addition, the bidder recognizes the right of the Owner to reject a bid if the bidder failed to furnish any required submittals on the date required by the bidding documents, or if the bid is in any way incomplete or irregular. Hence the County may award bids to other than the lowest bidder if in the judgment of the Board of Commissioners and the Bibb County Sheriff's Office the interest of the County will be best served by award to another.
- 1. Unless otherwise specified, manufacturer's names, trade names, brand names, information and/or catalog numbers listed herein are intended only to identify the quality level desired. They are not intended to limit competition. The bidder may offer any equivalent product that meets or exceeds the specification. If bids are based on equivalent products, the bidder shall indicate on the bid form the alternate manufacturer's name and catalog number and shall include complete descriptive literature and/or specifications along with proof that the proposed equivalent either meets or exceeds this specification. The Bibb County Sheriff's Office reserves the right to be the sole judge of what is equal and acceptable. If bidder fails to name a substitute, he shall furnish goods identical to the bid specifications.
