MOTIONS DEADLINE January 7: If this is the **first time** the case has been on a trial calendar, **particularized** motions are due by 4:00 pm. If the case is continued from a previous trial calendar, the deadline from the previous trial term is applicable. If you have motions still pending from a previous trial term, please notify Ms. Dees (BDees@maconbibb.us).

MOTION HEARINGS AND NON-JURY TRIALS January 18, 19 & 20

PLEA DATES January 12, 13 & 26: All negotiated pleas are expected to be entered or scheduled *before Pre-Trial Conference*. All pleas will be in person, unless otherwise authorized by the Court.

TRIAL ANNOUNCEMENTS January 21 are due by 3:30 pm. Announcements must be emailed to Ms. Dees (BDees@maconbibb.us). Cases that have been on a previous trial calendar are deemed "Ready" by the Court. In the rare case that an additional continuance is requested, the request must be in writing with good cause shown. "Ready" announcements should also indicate whether or not you object to the opposing party getting a continuance. Attorneys and Defendants must still appear for Pre-Trial Conferences unless expressly excused by the Court. Any requests for special scheduling considerations or protection should be made with the trial announcements. **Any attorney who misses the trial announcement deadline is subject to contempt.**

PRE-TRIAL CONFERENCES January 25 at 9:00 am and 1:00 pm: deadline to enter negotiated pleas. Any pleas entered after August 9th will be a blind plea.

DAILY JURY SELECTION February 7, 8, 9 & 10: 8:15 am – attorneys report; 8:30 am-jurors report.
