- 2. Page 8, Section II. D.1 lists the bid form as a required submittal, but it is not listed on page 25.
- A. These required documents are in the Attachment "A" on the website.
- 3. Bidder Minority Participation Goal form
  - a. Is there a Minority Participation Goal?
  - b. If so, what is the percentage?
  - c. If not, is this form required with our submittal:
  - A. The Minority Participation document is a requirement to be completed and there is no required Percentage.
- 4. Are There any pre-identified DMS locations?
