To: ALL PROSPECTIVE FIRMS

Re: INVITATION FOR BIDS: 23-018-LH, Pest Control Services

The Invitation for Bids, referenced above, is modified as follows:

1. Does this bid involve the need for rodent control?

Answer: Yes. This solicitation includes rodent control. Rodents are to be prevented and removed when present.

2. If so, would a rodent control device meet your bid's requirements, or are you purely looking for a service provider?

Answer: The successful contractor shall furnish qualified personnel, and all resources necessary to provide pest control services for Macon-Bibb County. All labor, materials, and equipment related costs to perform services for the extermination and control of pests of all kinds including, but not limited to, cockroaches, ants, mice rats, water bugs, fleas, silverfish, spiders, bees, lice, termites, ants plus other related pests and moisture control in Macon-Bibb County agencies. Pest Control to also include ancillary services for bed bugs, fleas, mosquito, structural fumigation, termite control, weed control, and wildlife control (see Attachment B).

3. Does the total bid price need to be the monthly price or annual price?

Answer: The total price encompasses the total Monthly cost for each of locations listed on Attachment B.

4. As far as addendum 3, are new companies permitted to attend the meeting or it is limited to the original bidders that attended the first meeting?

Answer: New companies can attend the pre-mandatory pre-bid meeting scheduled for 12/14/2022. See Addendum 3 for the time to appear.

5. Our insurance company is requesting the bond form from the organization. Is there a form on the website anywhere that we can send to them?

Answer: Macon-Bibb do not provide bond forms.
