Bid Schedule – Main Streets

The quantities listed below are an approximate estimate of the materials required to complete the roadway repair and resurfacing projects for the Main Streets list. The “Total Base Bid Price” is the bid amount which shall be used to award the 2022 LMIG paving contract to the successful bidder, based upon the Main Streets list.

Prior to beginning contract paving work on the main streets, the successful bidder will also be required to contact Mike Beard, with the Macon Water Authority, at (478) 256-9382, regarding locating / marking manholes and water valves prior to your road paving.

The 150-day contract period will proceed upon the successful bidder receiving the “Notice to Proceed” from our Procurement Office.
