If you submit a written case announcement as directed herein, you are excused from appearing at Calendar Call. While you are excused from appearing at Calendar Call if you submit a written case announcement, you must check back with our office or the Clerk's Office following Calendar Call to confirm whether your case has been continued, or if your case appears on the Ready Calendar for the Trial Week of December 9, 2024.

If the case is a Non-Jury matter, the attorney(s) and/or unrepresented parties still must appear at calendar call or make proper announcement in conformity with the above guidelines. Non-Jury matters may be heard during the trial week following jury trial matters.

Pre-Trial Conferences:

If less than eighteen (18) months have lapsed since the filing of the complaint, then the case may be continued by agreement without a motion. Such announcements may be submitted directly to the Judge's chambers by email (lbelle@maconbibb.us and gyoung@maconbibb.us) with a copy to opposing counsel or unrepresented parties. If there is a problem continuing a case, the Judge's office will contact you immediately.

Cases older than eighteen (18) months may be continued only by a motion granted by the Court. A joint motion for continuance may be made to the Court by filing the motion with the Clerk of Superior Court and providing the Judge with a copy and proposed order via mail or email. The copy of the joint motion and order must be received in chambers by the deadline to be considered by the Court.

Motions and Settlements:

The court does not know that motions are filed unless it receives a copy of the motion. Please instruct your personnel and take personal responsibility to see that the Court gets a copy of all motions and briefs.
