Such announcements may be submitted directly to the Judge's chambers by email (lbell@maconbibb.us and gyoung@maconbibb.us) with a copy to opposing counsel or unrepresented parties. If there is a problem continuing a case, the Judge's office will contact you immediately.

Cases older than eighteen (18) months may be continued only by a motion granted by the Court. A joint motion for continuance may be made to the Court by filing the motion with the Clerk of Superior Court and providing the Judge with a copy and proposed order via mail or email. The copy of the joint motion and order must be received in chambers by the deadline to be considered by the Court.
