If there is a problem continuing a case, the Judge’s office will contact you immediately.

Cases older than eighteen (18) months may be continued only by a motion granted by the Court. A joint motion for continuance may be made to the Court by filing the motion with the Clerk of Superior Court and providing the Judge with a copy and proposed order via mail or email. No faxed motions will be accepted. The copy of the joint motion and order must be received in chambers by the deadline to be considered by the Court.
