- The other party has not turned over property as ordered; or

If any of the following statements are true, you are strongly encourage to seek the advice of an attorney:

- The contempt involves custody or visitation and the other party no longer lives in Georgia; or
- I cannot find other party;
- The court order I want to enforce was made by the judge in another state.
