Permit Fee Schedule - January 1, 2014

COST VALUATION CALCULATION: General Contractor and Building Permits

NEW RESIDENTIAL*:

\$63.00/per sq. ft. of heated area

\$15.00/per sq. ft. for areas not heated or cooled, including accessory buildings, porches, decks, etc.

* New Residential and Remodel/Renovations are subject to a \$150.00 Plan Review Submittal fee.

PERMIT FEE CALCULATION: General Contractor and Building Permits Residential:

\$35.00 MINIMUM Permit Fee; \$4.00 per thousand or major portion when cost valuations exceeding \$8,499.99 plus \$35.00/trade as indicated on the application.

Example: *Cost valuation of \$17,500.00 with electrical, plumbing, mechanical and low voltage trades*
 $\$17,500.00 \text{ divided by } 1000 = 17.5 \text{ or } 18 \times \$4.00 = \$72.00 + (4 \times \$35.00 = \$140.00) = \212.00
The permit fee would be \$212.00.

COMMERCIAL*:

\$35.00 MINIMUM; \$4.00 per thousand of valuation or major portion as determined by ICC Valuation Tables and Plan Review.

* Commercial Buildings cost valuations based on current ICC Valuation Tables, subject to Plan Review.

SINGLE TRADE PERMITS

\$35.00 MINIMUM Permit Fee for cost valuations up to \$8,499.99.

\$4.00 per thousand or major fraction thereof for cost valuations exceeding \$8,499.99.

Each unit of a multi-unit building must be permitted separately.

WRECKING/ DEMOLITION PERMITS

\$35.00 per building for 1 & 2 Family Dwellings

\$50.00 per building for all buildings other than 1 & 2 Family Dwellings

Each parcel requires a separate permit; however, multiple buildings located on same parcel can be placed on a single permit.

Example: *3 commercial building located on the same parcel would be a fee of \$150.00.*

Example: *3 residential dwellings located on the same parcel would be a fee of \$105.00*

INDUSTRIALIZED BUILDINGS / DCA-BUILDINGS

\$100.00 shall be charged for set-up of structure (*including steps, ramps, decks, and foundation*)

\$35.00 shall be charged for each trade indicated on permit.

Example: $\$35.00 \text{ for electrical} + \$35.00 \text{ for plumbing} + \$35.00 \text{ for mechanical} + \$100.00 \text{ set-up} = \240.00
Permit fee would be \$205.00.

MANUFACTURED/MOBILE HOMES

\$50.00 shall be charged for set-up of the structure (including foundation, steps, decks, and ~~landings~~)

\$35.00 shall be charged for each trade permitted.

Example: $\$50.00 \text{ for set-up} + \$35.00 \text{ for plumbing} + \$35.00 \text{ for electrical} = \120.00 permit

APPEAL APPLICATION	\$250.00/per appeal
REINSPECTION FEE	\$35.00
CERTIFICATE OF OCCUPANCY on commercial buildings	\$100.00
PLAN REVIEW SUBMITTAL FEE* (Commercial and Residential)	\$150.00/each building
PLAN REVIEW SUBMITTAL FEE (canopy, signs, towers, boat docks, sprinkler & DCA)	\$35.00/each

* Additional Construction Document Review Fees may be required for those structures greater than 10,000 square feet in total building area.
