






# Registering and Logging in to the Portal

How to Guide will walk you through registering if you have any questions.



## Registering: What information is needed?









#### Registration Quick Facts:

Self-registration required to login to the site. Data keyed during self-registration should match the data provider by your employer. You can designate your own username and password and set preferred contact methods.

- Once your account is created, you will be taken back to the login screen to login with the newly created username/password.
- A 6 Digit Multi-Factor Authentication code will be sent to the email used for registration. Enter the 6 Digit Multi-Factor Authentication code to enter the site.
- Upon login, you will be prompted to set up security questions and answers. This is required.





#### Registration: Possible Issues



If you have previously registered for the site, you will receive this error message:

"You have already registered for this site. Please navigate to the Login screen to log in or the Forgot Password or Username pages to reset your account."

Please use the forgot username and/or password steps to regain access to the site.

Set up your 'Preferred Contact Method' by going to 'MYACCOUNT' on the menu. The E-mail/Phone contact can be added/updated. Use the dropdown to select E-mail or Phone as your Preferred Contact Method

You may also maintain your security questions under the 'MYACCOUNT' tab.

If your data has not been provided by the county, you will receive an error message:

"You do not have access to use this site, please contact the Retirement Service Center at (833) 899-4400"

When this happens, please contact the ACCG Retirement Service Center at (833) 899-4400 for assistance.




