ADDENDUM # 2

To: ALL PROSPECTIVE FIRMS

Re: INVITATION FOR BIDS: 26-046-LH, Debris Removal Services

The Invitation for Bids, referenced above, is modified as follows:

1. What tipping fees will be regarded as a pass through?

Answer: Haul out of reduced debris to the County approved final disposal site, the County will reimburse the contractor for such fees on a dollar-for-dollar basis. The method of the final disposition, whether chipping or burning, will be determined by the County.

2. Is there a virtual option for the pre-bid?

Answer: Yes. Please refer to Addendum 1.

3. We are in the process of reviewing ITB and wanted to find out if the County only wants 1 original proposal submitted back? I didn't see anything regarding the number of copies that you guys want returned.

Answer: Provide 1 original proposal and 5 copies of the proposal along with the flash drive.

4. How many original(s), copy(s), and electronic copy(s) of the proposal are required?

Answer: This information can be located in the solicitation.

5. What is the term of the contract?

Answer: 5 years 5 years. Initial contract year with 4 renewals.

6. Addendum 1 provided attachment B – EMA Debris Removal Services Price Form. Are we to provide this form in addition to the Bid Price Form which asks for the total bid price?

Answer: Both bid forms are to be completed and submitted with the bid proposal.

7. The RFP mentions a Schedule 2 pricing sheet under Emergency Road Clearance. Will the County be providing an additional pricing sheet for these services?

Answer: There is no Schedule 2 pricing sheet as referenced under section "IV Emergency Road Clearance.". Please refer to pricing sheet titled "Attachment B" posted on the Macon-Bibb Procurement website. Please click link below to retrieve the pricing sheet.

8. Are there any pre-identified dumpsites? If so, can you please provide the locations.

12. What is the term of this contract, and are there any renewal options once the initial period is completed?

Answer: Please refer to question #5 of this addendum. There will be renewable options after the initial period of the contract. 5 years. Initial contract year with 4 renewals.

13. Will the landfill/tipping fees be treated as a pass-through expense, whereby the contractor pays the tipping fees and invoices the County at cost without any markup?

14. What are the clauses for termination of the contract?

Answer: This information is not available at this time.

15. Who pays tipping fees?

Answer: Please refer to question #1 for answer.

16. Are trees and stumps same price regardless of size? Will this be amended?

Answer: Yes. If an amendment transpires, it will be posted as an addendum

17. Will there be a haul-out line added?

Answer: The cost for hauling out of the debris should be built into the cost for each type of debris.
