Cases older than eighteen (18) months may be continued **only** by a motion **granted** by the Court. A joint

motion for continuance may be made to the Court by filing the motion with the Clerk of Superior Court and providing the Judge with a copy and proposed order via mail or email. The copy of the joint motion and order **must** be received in chambers by the deadline to be considered by the Court.
